CODE OF ETHICS OF ANIMA

Anima has approved in our last General Assembly meeting held in April, a very important document that will guide our activity in future, protecting our values and our commitment of not being involved in any way in any political affair. Foremost, our Code of Ethics stands as an instrument of animal dignity, being a tool comprised of key generic principles that guide the fulfillment of values and nurture the bond between pets and the people who care for them. Likewise, it spells out the very nature of our organization, the standards of conduct of our collaborators, and our profound and permanent principles guiding everyday decisions. Even when those decisions appear to be very hard to take, our code sets out specific areas of concern and points the way to the right actions, policies and decisions.

This code applies to our employees, volunteers, board members, or anyone who may act on behalf of ANIMA. That includes our president, officers, board of directors, executive committee members, supervisory body, fulltime and part-time employees and agents. We expect each of these individuals and anyone else who works or acts on behalf of ANIMA to understand and uphold the principles and policies spelled out in this Code. No one – at any level of management – can permit or demand the infringement of our policies or the Code of Ethics. Indeed it represents the moral foundation for our organization. Furthermore, it is suggested that all citizens adopting animals from ANIMA adhere to this Code of Ethics.,
