Dear Secretary Lionel Leong,

CANIDROME – PLEASE HELP US!

Following our last letters of July and November 2016, ref. 006-07-2017-SEF and ref. 17-11-2017-SEF, with no answers at all, we have less than 1.5 years to find a proper solution for those animals.

The important thing now is to prepare an effective way to solve this problem in Macau!

Anima was the local leader of a campaign to close the Canidrome and wants also to be part of the solution. We are willing to work with the Government, taking care, for a minimum period of one year, of all animals in Canidrome. This period is the minimum required for such space to be properly reordered by the Government and reverted to the community as we all know it is what our people want!

Anima will try to obtain the necessary financial support to be capable to deal with these animals and prepare their adoption (we have now 240 international adopters and we believe we can have more if we are confirmed to receive the greyhounds). We believe also that the adoption of so many animals is only possible internationally!


That's the reason why we have been asking the Government for so long, with no answer at all, to help us and promote internationally Macau as a Chinese town with modern values!

We know that DICJ prefers to reply to international organizations than to us, forgetting that we have around 180 international organizations supporting and keeping in touch with us!

Once again, I ask Your Excellency to convince the Macau (Yat Yuen) Canidrome Company Ltd and through it the other greyhounds owners, to provide all those animals to Anima.

I reinforce again that It would be internationally a disaster to Macau if something bad were to happen to those animals that are still alive there (around 600 now) or if they were sent to Mainland China or Vietnam or any other area with no proper laws to protect them.

Believing once again that Your Excellency will be attentive to the development of this issue and support Anima, please accept in advance our best thanks.
